Proclamation

WHEREAS, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 16,000 students and

WHEREAS, the Associated Students of Ohlone College (ASOC) passed a Students First Proclamation (see ATTACHMENT 1). In this proclamation, ASOC asked to have Article VI Source of Power which gives their College President the right to supersede their authority removed from their Constitution.

Student Government Bylaws and Constitutions. ASOC found that nearly 90% do not have supremacy clauses (see ATTACHMENT 1) similar to ASOC's Article IX Source of Power. The ASOC argued that students have a First Amendment right of freedom of speech and it is needed to represent their student's interests.

WHEREAS, ASU's Mission Statement² states that the "Associated Students Incorporated governances, freedom of speech, and security, and get students the form, let it be
