- " #E\$EAS, The Associated Students Incorporated (ASI) of the California State University, East Bay (CSU East Bay) is the singular (ed) voice of the students of this campus) and

- " #E\$EAS, Existing law, AB 131, allows that a person who has attended high school in California for one or more years, has graduated from that high school or attained the equivalent, has registered at or attends an accredited institution of higher education and if he or she is without lawful immigrant status, be exempted from paying the nonresident tuition at the California Community Colleges and the California State University and remain confidential) and
- " #E\$EAS, Assembly Bill 131 would amend the California Higher Education Act, as of January 1, 2011, to require the Trustees of the California State University and the Board of Governors of the California Community Colleges, and to request the Regents, to establish procedures and forms that enable students who are exempt from paying nonresident tuition under the above described provision, or who meet equivalent requirements adopted by the Regents, to apply for, and participate in, all student aid programs
