- 2. <u>Visa Appointment you must schedule a visappointment at U.S Embassy</u>, preferably in your home countery, obtain a new F1 visa
 - a. You will have to follow the instructions given the embassy website regarding timing and documentation required.
 - x Please check with your U.S. Embassy if you are required to obtain a new is a if your current fl visa is valid
- 3. <u>Return DateYou are not allowed to return to the USA until 30 days produce</u> start of the program date listed on your I-20.
